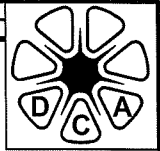

# DARWIN DIVISION OF THE DEVELOPMENT CONSENT AUTHORITY

## Information for invitees attending meetings

- The Development Consent Authority is a consent authority under the *Planning Act*. It meets in the Brolga Conference Room, Novotel Darwin Atrium, 100 The Esplanade, Darwin. The members are appointed by the Minister for the Darwin Division are:

Ross Baynes	Member

- The Authority receives administrative support and professional advice from the Development Assessment Services branch of the Department of Lands, Planning and the Environment and its officers attend the meeting. They do not take part in making decisions of the Authority.
- Council may have a representative who attends the meeting to advise the Authority of its views.
- The evidentiary stage of the meeting is open to the public and the media.
- The meeting is divided into sessions of an hour for the convenience of those appearing before the Authority. You have been invited to attend at a particular time. It is anticipated that the matter you have an interest in will be heard within an hour of that time. You may attend to make a presentation or simply observe the hearing. Please wait until invited in to the relevant session.
- The Authority will usually deliberate later in the day.

### People Making Submissions:

- The Chairman will invite those wishing to speak to their submissions to address the Authority. If there are many people with similar concerns they may be invited to appoint a spokesperson. If the points of concern to you have been expressed by a previous speaker you only need to advise that you agree. Members have full copies of your submission and therefore there is no need to repeat the detail. The Authority members may ask you questions.
- The Chairman will then give the applicant the right of reply.
- **Two working days following the meeting, submitters may ring the Secretary of the Development Consent Authority on telephone 8999 6044 to receive informal advice regarding the Authority's decision on development and subdivision or consolidation applications.** It is the policy of the Authority to advise other persons of the decision only after the applicant has been advised. Formal notification by means of a Notice of Determination, Notice of Consent with Development Permit or Notice of Refusal may take some time following the meeting.
- Third party appeal rights may be available to persons who made submissions depending upon the type and location of the development application. There is no third party right of appeal in relation to applications for subdivision or consolidation.
